Nation vows to further deepen opening-up

State Council executive meeting calls for more efforts to attract foreign investment

China will further open up its market to attract foreign investment, in order to better meet the needs of the world's largest economy in the new era, according to a statement by the State Council on Wednesday.

The move was chosen by Premier Li Qiang, decided that the government must “open up the country more” and “attract more foreign investment, focusing on improving access to markets, creating a more favorable environment for the manufacturing and information sectors, and making greater efforts to expand opening up of service sectors.”

Domestic and foreign companies will be given more opportunities to participate in various sectors, including infrastructure construction, high-tech manufacturing, and the pharmaceutical and medical device sectors, among others.

Additionally, it was noted at the meeting that the government would continue to support the implementation of the Belt and Road Initiative, and encourage more Chinese to work in other countries.

“In the first few months of this year, we have seen some signs of recovery for attracted foreign investment,”

Notably, in the first few months of this year, China's foreign direct investment increased by 10.4% year-on-year, according to the National Bureau of Statistics.

This represents a significant improvement compared with the same period last year, when FDI growth in China improved in January.

Foreign businesses operating in China are also expected to increase their investment expectations and confidence in China's market, according to the statement.
